The California Retailers Association opposes the current proposed draft regulations for under-inflated vehicle tires, because of the cost to retail businesses in this time of severe recession, and because we believe that the objective can be met by a much simpler regulatory approach. Our association represents retail chains that provide automotive services and repair, and tire sales and service facilities, whether attached to retail stores or free-standing.

### Summary of Regulation

The proposed regulation will require automotive service providers to purchase ANSI standard B40.1 compliant tire pressure gauges. Purchase of •gtire inflation reference manuals•h is also mandated, as is a tire pressure check on all vehicles brought in for service. Service providers must document that the check was performed, write down the actual pressure of the tire and retain records for potential inspections, audits and enforcement.

### Costs

The staff report predicts a cost of over \$100 million per year to implement the regulation. Costs include the cost of the specific tire gauges (\$25 each), the cost of the manuals (\$50 each) and the additional labor costs of checking the tires and noting the pressure. Costs will also include the annual ongoing cost of document retention (a cost particularly for small businesses, which do not have adequate on-site storage capability and must pay a document retention service).

### Reasons for Opposition

- œ It is completely unnecessary for the State to determine that only one type of tire gauge is permissible. For decades people have been able to accurately read tire gauges that were not •gANSI approved•h, and the \$25 cost of the gauge is ridiculously high. Additionally, these gauges only have a life expectancy of 2 years, so businesses must continually be replacing them.

- œ It is also completely unnecessary for the State to mandate purchase of a \$50 manual for businesses to inform their employees how to do tire pressure check. It is duplicative because the recommended tire pressure information is on the tire itself, on the



vehicle door sticker, or is calculable. This is not rocket science--\$50 manuals should NOT be required. Nor should the manuals have to be replaced and/or updated every 3 years, as the regulations state.

#### Proposed Alternative

The regulation is projected to save California 90 million gallons of gasoline (and resultant GHG emissions) by 2010, and to prolong tire life by reducing tire tread wear. In the spirit of facilitating the emission reductions per CARB's mandate, we offer the following compromise:

- Require auto service providers to conduct tire pressure checks when vehicles are brought in for service.
- Require documentation to be made at the time the tire pressure check is conducted, and require this documentation to be retained for X number of years.
- Permit auto service providers the option of documenting the tire pressure check by using their own work order system, or by using a CARB-provided format for documenting the check. In checking with our member companies, there are those who want to use a separate form provided by the State, so as not to have to redo, reprint, and revise their existing systems. There are other retailers who do not want to have to keep track of two different forms and want the ability to add documentation of tire pressure check to their service performance documentation. Allowing retailers to choose among these two options provides flexibility for different retail tradestyles and saves cost to the retailer.
- Eliminate the requirement for specific gauges and manuals to be purchased.

We believe this alternative approach secures the desired emission reduction goals while reducing cost to businesses for compliance.

Board has deleted the definition of "Pure Nitrogen" as listed in article 10, section (c), Resolution 09-25, Attachment B, Posted May 6, 2009. I ask that "Pure Nitrogen" definition be restored in the final regulatory language for the following reasons.

a. Nitrogen must be defined because it is mentioned in the document at other places and may not be clearly known to consumers and ASPs.

b. Nitrogen must be differentiated from "air" as it is referenced as an alternate inflatant.

c. Nitrogen purity must be defined otherwise its purity will be subject to misinterpretation and misrepresentation. Its use can be fraudulent resulting in overcharging of consumer. For example, ASPs may charge for "nitrogen" but use air claiming that it has 78.1% purity.

d. To avoid this confusion, a simple solution would be for CA ARB to retain the definition of "Pure Nitrogen" as listed in the original Attachment B.

On behalf of the Automotive Service Councils of California (ASCCA), we are writing to provide comments to the proposed amendments to the Proposed Amendments to Regulation to Reduce Greenhouse Gas Emissions from Vehicles Operating with Under Inflated Tires. The ASCCA is a statewide organization that represents 1,000 automotive repair facilities, including smog shops.

We appreciate the revisions and modifications that were made to these latest proposed regulations based upon our letter dated March 20, 2009. The ASCCA has the following additional comments and suggestions:

- 1) The proposed regulations should apply to all automotive service providers registered with the Bureau of Automotive Repair (BAR) that perform automotive repair services.
- 2) The proposed regulations are not clear as to whether the service provider must check inflation of vehicle tires while the tire is "hot" or wait for a period of time and check when the tire is "cold". This concern was raised in prior correspondence and at the Air Resources Board workshops. It still has not been adequately addressed in the proposed amended regulations.
- 3) The proposed regulation does not address the issue of oversized tires as well as the modification of a vehicle to accommodate such. We request that this matter be addressed in the proposed regulations.
- 4) As you are well aware, the BAR has regulatory oversight of the automotive repair dealers in the state. BAR has the expertise and

personnel to properly oversee the enforcement of these proposed regulation rather than the Air Resources Board. As such, we request that the BAR act as the authorized representative to enforce this regulation under existing law, that the proposed amended regulations reflect such enforcement and that Section 95550 (e) be deleted in its entirety.

5) Under current law, the BAR requires that an automotive repair dealer obtain authorization from the customer before performing any diagnoses or repairs on vehicle. These regulations do not address the situation whereby a customer refuses, for whatever reason, to provide authorization to the automotive repair dealer to have the tires checked and inflated. We further recommend that a specific exemption be included for such an instance and that such be reflected on the vehicle service invoice.

ASCCA believes that unless the above concerns are adequately addressed in the proposed regulations, the tire inflation program may not end up reducing greenhouse gas emissions and, in fact, may be more detrimental to the environment than beneficial.

TO BE FREE OF MISINTERPRETATION AND TO GAIN PROPER TIRE INFLATION RETENTION AND REDUCED OXIDATIVE DEGRADATION BENEFITS, IT IS VERY IMPORTANT THAT NITROGEN PURITY BE CLEARLY STATED IN ARTICLE 10, SECTION (C), RESOLUTION 09-25, ATTACHMENT B THAT WAS POSTED MAY 6, 2009.

BASED UPON PEER REVIEWED SCIENTIFIC STUDIES, THE TIRE'S INFLATION GAS REQUIRES AT LEAST 95% NITROGEN PURITY AND NOT MORE THAN 5% RUBBER WEAKENING REACTIVE OXYGEN. TO MEET THIS ESTABLISHED CHEMICAL REQUIREMENT DURING THE TIRE INFLATION PROCESS, THE NITROGEN PURITY OF THE INFLATION GAS MUST BE IN EXCESS OF 95% TO OFFSET ANY RESIDUAL OXYGEN THAT CANNOT BE EFFECTIVELY PURGED. THE READILY AND EASY COMMERCIAL AVAILABILITY OF 98% TO 99.9% NITROGEN MAKES IT REASONABLE TO HAVE THE CALIFORNIA RESOLUTION NOT CREAT CONFUSION AND CLEARLY DEFINE NITROGEN'S REQUIRED PURITY BE NO LESS THAN 98%.

THE PRESENT NON QUANTITATIVE WORDING OF "NITROGEN" INSTEAD OF THE MORE PRECISE WORDING OF "NITROGEN OF AT LEAST 98% PURITY" (IE: HIGH PURITY) WOULD ALLOW SELLERS TO INNOCENTLY OR INTENTIONALLY CONFUSE THE CONSUMER AND COMPROMISE NITROGEN'S BENEFITS AS WELL AS THE AGENCIES INTENT BY CLAIMING THAT AIR WITH IT'S NORMAL 78% NITROGEN MAKE-UP IS "NITROGEN INFLATION".

Proposed Amendments to the Regulation to Reduce Greenhouse Gas Emissions from Vehicles Operating with Under Inflated Tires

Dear Mr. Goldstene:

I am writing on behalf of the California Tire Dealers Association, which represents several hundred small and independent tire retailers throughout the state. While we applaud a number of changes the ARB has made in the latest draft of the proposed regulation, we still must take issue with portions of Section 95550 of Article 1, Chapter 1, Subchapter 10, Division 3, Title, California Code of Regulations.

- A number of our members use the portable "pencil" gauges that are easily accessible and clip to a worker's shirt. These gauges are generally accurate to +/- 4 psi. We support a change in Section 95550 (d) (1) (C) from the +/- 2 psi standard.

- Section 95550 (c) (14) "Unsafe Tires." While we support the proposal for Auto Service Providers not to inflate unsafe tires, in the definition portion of the regulation, Section 95550 (c), it refers to tire "age" as one of the reasons that tires become unsafe. That issue is the subject of significant debate, lawsuits, and legislation. Since NHTSA has promised further testing on the issue, and since the cause of a tire becoming unsafe is not pertinent to the definition, we suggest you simply eliminate the controversial issue of tire "age" as a causal factor and suggest the following wording for Section 95550 (c) 14:

"Unsafe Tires" means any tire considered unsafe in accordance with standard industry practices, due to tire tread wear, age, tread irregularity, or damage. Examples include any tire with exposed ply or cord, sidewall crack, bulge, knot, or ply separation.

- A minor correction is needed for Section 95550 (d) (3)

with its reference to definition (13) rather than (14): (B) the tires are determined by the automotive service provider to be unsafe, as defined in § 95550 (c) (13) (14); or

Having said this, Ventech is concerned that any revisions to the under inflated tire regulatory program adopted earlier by CARB, be made to strengthen the program and broaden its reach versus weakening or limiting its applicability. The technology to capture these carbon emissions is available now through systems like ours. Please be aware that any changes, no matter how small-seeming will be watched around the world and will be a signal sent that will impact our market and more importantly the reduction of the all-important associated emissions. We urge sensitivity to this impact and ask that no changes to the program be made that limit the program's reach.

I just was informed about this insane bill that your going to try to pass about tire pressure regulation!!! I relocated here from Airizona who has one of the toughest Air Quality Standards in the nation (Maricopa County). If you really need to generate revenue start with some simple laws that should also apply here as well.

1. All dump trucks and Vehicles that carry gravel, sand dirt, waste that can produce any type of dust must be Tarped while on main roads at all times. This does include if you are empty after dumping your load due to the fact the belly or bed is not clean and dust still rises into the air. This dust in the air (Particulates) causes the Air quality to become worse trapping gases and supposedly effecting the climate. They impose a fine if caught traveling with thier bed un tarped starting at 500.00. This applies to all types of earthmoving and trash equipment.

2. Implement that all construction sites maintain a track out control device for entrance and exit to an unpaved jobsite. The trackout device must be 25' wide by 50' long with 4" of track out rock. This rock is to be maintained on a regular basis to help clean the tires of trucks and vehicles driving on and off the job sites. If there is no track out control device it is an automatic (In AZ) \$ 10,000.00 fine. If the trackout device is not to proper specs it is also a fine. 4. Any site with earthmoving shall have a dust inspector (unanounced) montior the job site. They shall be trained in what is and isnt acceptable dust content. If there is a large quantity of dust observed there will be a dust ticket issued and fines start at 14K.

5. Any site with exposed earth shal have a crust over the entire site while working and also while not working on the job site. If anyone observes excessive dust blowing they can call in a complaint and if an inspector verifies there is blowing dust and no attempts to supress the dust there will be a fine.

6. Every builder, developer, contractor shall have in there posession at the jobsite a Dust permit. This also shall be posted on a sign visible to the public for dust complaints with a phone number to contact Aor quality Department. This also generates

revenue for the government at a county level for the cost of a dust permit is (In AZ) 300.00 avg.

7. The state shall train contractors in the earthmoving, excavating industry, concrete paving, Underground pipe laying, etc. All measures required to control dust and be certified by attending a class which the developer must pay for. This also generate dollars for the counties.

8. The State or County shall hire and train "Air Quality Inspectors" to monitor dust control from the smallest demolition to the largest earth moving sites.

An equation from elementary physics shows that this is a real tail-chaser of a law. The pressure of a given volume of gas varies directly with temperature. Simply, when the temperature goes up, pressure goes up; when the temperature goes down, pressure goes down. Since ambient temperature can vary by more than 20 degrees on a given day and the tire temperature can vary significantly more due to friction, road temperature, and load, pressure will vary significantly throughout the day. This variance can be 15% or more in a given day. That means a 35 lb psi tire can go as high as 40.4 lbs or as low as 29.6 lbs without adjusting the fill of air.

Your operating ranges are too narrow and your penalties are too high.

This is not an area that should be subject to regulation.

The manufacturer's recommended inflation pressures are only good for average driving conditions on the original tires. They are useless on replacement tires or non-average driving conditions such as greater freeway or around town driving. Proper pressures can only be determined by monitoring inflation pressure and wear patterns over an extended time.

3) I heard you removed the documentation requirement, so the law is unenforceable and therefore not an appropriate use of public resources. If documentation was required, I would refer you back to items one (1) and two (2).

I have the following comments with respect to the proposed adoption of a new Section 95550, Title 17, California Code of Regulations which would provide all Automotive Service Providers to perform tire inflation service on all passenger vehicles that are brought in for service or repair (the "Proposed Regulation").

1. The Legislature has Unconstitutionally Delegated Uncontrolled Power the Air Resources Board (the "Board") to Adopt Regulations.

The Board cites the following sections of the California Health & Safety Code as authority for Proposed Regulation: Sections 38510, 38560, 39600, and 39601. Section 38510 simply charges the Board with authority for "monitoring and regulating sources of emissions". Section 38560 simply directs the Board to adopt regulations that "shall achieve the maximum technologically feasible and cost-effective reductions in greenhouse gas emissions from those sources or categories of sources, in furtherance of achieving the statewide greenhouse gas emissions limit." Section 39600 requires the Board to do all acts as may be necessary and proper for the execution of its powers and duties. Section 39601 requires that the Board adopt regulations in compliance with the rulemaking provisions of the California Administrative Procedure Act.

Nearly all human activity involves the emission of greenhouse gasses. For example, the U.S. Environmental Protection Agency estimates that the average person emits 2.3 pounds (1 kg.) of carbon dioxide simply by breathing. This means that Californians emit approximately 14 million metric tons of carbon dioxide per year just by breathing. Other activities, whether personal or commercial, will almost invariably result in the emission of carbon dioxide or other greenhouse gases.

Because the legislature has bestowed on the Board the authority to regulate greenhouse gas emissions, it has delegated to the Board authority to regulate virtually all human activity. Moreover, the legislature has given the Board absolute discretion under these statutes. Thus, the legislature has provided no limits on what the Board can regulate or standards for how the Board regulates. Because the legislature's delegation to the Board is so broad, there is simply no way for a reviewing court, or anyone else, to determine whether the Board has kept within its delegated authority. For these reasons, the statutes cited by the Board as authority for the Proposed Regulation constitute an unconstitutional delegation of legislative power. See *Dominguez Land Corp. v. Daugherty*, 196 Cal. 468, 484 (1925) ("It is well

settled that the legislature may commit to an administrative officer the power to determine whether the facts of a particular case bring it within a rule or standard previously established by the legislature for his governance . . . . If, however, no standard by which the officer is to be governed be prescribed by the lawmakers, then there is an attempt to entrust a mere administrative officer with the plenary power of the legislature, and there will then be no guard against possible arbitrary action.") and People's Federal Savings & Loan Association v. State Franchise Tax Board, 110 Cal. App. 2d 696, 700 (1952) ("The delegation of such uncontrolled power was void as an attempt to delegate legislative power to an administrative officer.").

The issue of unfettered delegation is not merely academic. The Board is not elected. Thus Board members are not directly accountable to the People of California. Further, the absence of any standards makes it all but impossible for a court to meaningfully review the Board's actions.

2. The Changes in the Modified Text are Substantial and are not Sufficiently Related to the Original Text.

The modified text of the Proposed Regulation makes several substantial changes. For example, the modified text includes a new requirement that customers affirm certain matters in order to decline service. Further, the modified text includes a new requirement with respect to disclosures on the vehicle service invoice. A reasonable member of the directly affected public is an ordinary consumer. Ordinary consumers would not have determined from the original notice that these changes would have resulted. 1 CCR Section 42. Accordingly, the modified text should have been made available for at least 45 days. Cal. Govt. Code Sections 11346.4 & 11346.8(c).

3. The Proposed Regulation will Adversely Affect Consumers.

The Proposed Regulation will adversely affect consumers. In most cases, consumers will not be specifically seeking tire inflation services when bringing their vehicle to an automotive service provider. Thus, they are unlikely to have engaged in comparison-shopping for tire inflation services before bringing the car in for service. Automotive service providers are likely to take advantage of this fact by telling the consumer that they are legally obligated to perform a tire check and inflation and that they must note any refusal of the service on the invoice. Nothing in the Proposed Regulation requires the automotive service provider to disclose to the consumer (either orally or in writing) that the service may be declined. Moreover, a consumer who has taken the time to take his vehicle to the provider is not likely to want to incur additional time and expense in taking his car to another provider who offers the service at a lower cost. As a result, significant price gouging is likely to occur if the Proposed Regulation is adopted.

4. The Board is Implicitly Concluding that the People of California do not, and Cannot, make Rational Decisions.

Assuming the Board's assumptions concerning the costs associated with under inflated tires are correct and that the public would save money through proper inflation, the Board does explain why it believes that people do not and will not maintain proper tire inflation. Thus, implicit in the Board's Proposed

Regulation is the conclusion that people will not, even if informed, make economically rational decisions. There is no basis for the Board's view that Californians are inherently unable to make rational decisions or properly maintain their own property.

In conclusion, the Proposed Regulation represents an unconstitutional delegation of legislative power to the Board; the modified text is not sufficiently related to the originally proposed text; the Proposed Regulation will likely result in price gouging; and the Board should not presume that the people cannot make rational decisions.

The Automotive Service Councils of California (ASCCA) is a statewide organization that represents 1,000 automotive repair facilities in the State, including smog shops.

ASCCA has participated and been actively involved in the under inflated tire regulation process from its inception. ASCCA representatives and members have attended workshops and provided comments and suggestions to improve the regulation for both repair shops and consumers. The ASSCA has also provided written comments to the previous versions of the regulation.

The original intent was to simply codify, into regulation, the exiting voluntary practice of checking and inflating tires. The current practice is very simple and straightforward.

Unfortunately, the latest version of the regulation creates unnecessary costs and administrative burdens for both repairs shops and consumers by requiring an unreasonable amount of documentation. Furthermore, it subjects both repair shops and consumers to severe penalties even for simple oversights or mistakes. This process started out as a good idea but now has become so convoluted and complicated that it will create many unintended consequences:

ASCCA has the following specific comments and suggestions:

1) Section 95550 (d) (5), which requires consumers to prove that they performed a tire check and inflate service within the last 30 days and provide supporting documentation or agree to perform a tire pressure check and inflate service within the next 7 days,

which must be documented on the repair shop invoice, is unnecessary and frankly over the top.

The customer should have the right to decline the check and inflate service. Period. Requiring evidence and documentation that they performed or will perform is unnecessary. The entire section should be deleted.

2) The proposed regulations should apply to all automotive service providers registered with the Bureau of Automotive Repair (BAR) that perform automotive repair services.

3) It is unclear as to whether the service provider must check inflation of vehicle tires while the tire is "hot" or wait for a period of time and check when the tire is "cold". This concern has been raised in prior correspondence and at the Air Resources Board workshops. It still has not been adequately addressed in the latest version of the regulations.

4) As you are well aware, the BAR has regulatory oversight of the automotive repair dealers in the state. BAR has the expertise and personnel to properly oversee the enforcement of this proposed regulation rather than the Air Resources Board. We hereby request that the BAR act as the authorized representative to enforce this regulation under existing law and that the proposed amended regulations reflect such enforcement. Furthermore, we request that section 95550 (e) Penalties and Injunctions be deleted.

The regulation, as drafted, will create another layer of unnecessary administrative paper work, increase in costs, frustration and confusion for both the repair shop and the customer. We respectfully request that revisions be made to address the above concerns, or in the alternative drop the regulation and allow the automotive industry to continue to provide check and inflate service on a voluntary basis.

1) This rule will cause most shops to institute an extra charge for the "tire pressure service" whether or not such a service was previously part of the standard package performed. The rule should place some reasonable limit on the amount of such a charge. Based on experience with the "hazardous waste" fee that's always added to service bills now (which is not required by law), the amount will most likely be in the \$10-20 range at most shops, which in the case of a basic oil change service could almost double the cost to the vehicle operator and would discourage performance of period service which is needed to maintain safe and emission-minimizing operation.

2) The rule should also require that gas stations make free air available to customers to encourage self-service tire pressure maintenance. Most no longer maintain air hoses, or if they do they charge \$1 or more for the amount of air needed to check and adjust all tires on a vehicle.

I too have some concerns about your proposed legislation.

1) You have not adequately addressed the tire temperature issue. If all the printed specifications are for cold tires, and if we are required to inflate only to the vehicle manufacturer's specified pressure, then any tires we check and inflate when hot will still be underinflated. You specifically say not to drop the hot tire pressure to the cold standard else the tire will be underinflated. I suggest that because there is no standard for proper inflation for a hot tire that this proposed regulation is a fool's quest and therefore should be abandoned.

2) You have made it impossible for industry to comment on your proposed "Best Practices" document - prior to adopting this regulation - since it does not yet exist. We do not have the ability to examine and comment on how you propose to address the issues of non-original tire sizes, non-original wheel sizes, non-original load ratings, and all temperatures other than cold. This is unfair to industry. I request that you do not proceed with this regulation until a "best practices" document has been created and commented upon by industry.

3) It is unclear how an ARD is to handle this proposed regulation in a number of cases:

(a) For example, we do not currently write a work order if a customer stops by to have us replace a brake light bulb or wiper blades. Yes, we do sell them the part, but we do not charge them any labor charge to install the part they just bought. Does this regulation apply in this case? Clearly we are an ARD and not a parts store.

(b) We often have a Body Shop bring us a vehicle to read and clear airbag codes after they have done a repair. They do not own the car and they only want us to perform this one task. Do we need to force them to have the tire pressures checked? They are my customer, but they do not own the car.

4) Why did you exempt Body Shops? They will often have a car for weeks until it is repaired. Shouldn't it be just as important for them to check that car's tire pressures before releasing it back to the customer?

The Automotive Service Councils of California (ASCCA) is a statewide organization that represents 1,000 automotive repair facilities in the State, including smog shops.

ASCCA has participated and been actively involved in the under inflated tire regulation process from its inception. ASCCA representatives and members have attended workshops and provided comments and suggestions to improve the regulation for both repair shops and consumers. The ASSCA has also provided written comments to the previous versions of the regulation.

The original intent was to simply codify, into regulation, the exiting voluntary practice of checking and inflating tires. The current practice is very simple and straightforward.

Unfortunately, the latest version of the regulation creates unnecessary costs and administrative burdens for both repairs shops and consumers by requiring an unreasonable amount of documentation. Furthermore, it subjects both repair shops and consumers to severe penalties even for simple oversights or mistakes. This process started out as a good idea but now has become so convoluted and complicated that it will create many unintended consequences:

ASCCA has the following specific comments and suggestions:

1) Section 95550 (d) (5) provides that a customer may decline the check and inflate service if the customer affirms that they performed a tire check and inflate service within the last 30 days or agree to perform a tire pressure check and inflate service with the next seven days. Requiring the customer to affirm and the repair shop to document this is simply unnecessary and frankly over

the top.

The customer should have a right to decline the check and inflate service. Period. Requiring affirmations is crazy. Is it the intent of the Air Resources Board to make criminals out of customers that don't inflate their vehicle tires? Requiring affirmations and documentation should be deleted.

2) The proposed regulations should apply to all automotive service providers registered with the Bureau of Automotive Repair (BAR) that perform automotive repair services.

3) It is unclear as to whether the service provider must check inflation of vehicle tires while the tire is "hot" or wait for a period of time and check when the tire is "cold". This concern has been raised in prior correspondence and at the Air Resources Board workshops. It still has not been adequately addressed in the latest version of the regulations.

4) As you are well aware, the BAR has regulatory oversight of the automotive repair dealers in the state. BAR has the expertise and personnel to properly oversee the enforcement of this proposed regulation rather than the Air Resources Board. We hereby request that the BAR act as the authorized representative to enforce this regulation under existing law and that the proposed amended regulations reflect such enforcement. Furthermore, we request that section 95550 (e) Penalties and Injunctions be deleted.

The regulation, as drafted, will create another layer of unnecessary administrative paper work, increase in costs, frustration and confusion for both the repair shop and the customer. We respectfully request that revisions be made to address the above concerns, or in the alternative drop the regulation and allow the automotive industry to continue to provide check and inflate service on a voluntary basis.

Please note that:

1) Section 95550 (c) (13) defines "Under Inflated Tire" as "...a tire that is one pound per square inch (psi) or more below the recommended tire pressure rating."

2) Section 95550 (d)(1)(C) mandates the pressure be read using a pressure gauge that is accurate to +/- two pounds per square inch (2 psi)

It would seem that specifying an instrument to read the required 1 psi pressure rating that is inherently 200% in error, is counter intuitive to the regulations intent.

In regards to "Definitions" (16) "Vehicle Service Invoice" should be worded to include that if a separate tire inspection is performed that the subsequent inspection can include identifying items that would align the Vehicle Service Invoice to the Tire Inspection. These can be Vehicle Identification Number (VIN), or other indentifying items. The term "Invoice" connotes that there is a fee associated with this function. In reality this could be a no fee service from the ASP and therefore no invoice generated. A Tire Inspection form should suffice as standalone documentation for the inflations service performed.

Additionally, the reporting requirements do not specifically address the electronic recording and storage that is important to generating and retaining the records required for such a large data base as this regulation will generate. If this regulation is to improve air quality, having to harvest trees and produce the paper to meet these reporting and retention requirements are also counter intuitive to the regulation's intent and our future. The ASP should not have to keep paper records if electronic reproduction can be retained and accessed as required.

Addressing (109) "Tire Inflations Reference" with no recognizable authority that publishes an 'industry standard', the regulations need to be specific as to where the ASP needs to acquire the proper air pressure settings. For lack of alternative, tire pressure setting should be taken from the vehicle itself (door placard, owner's manual, etc.) and noted on the Tire Inspection form or invoice.
