EXECUTIVE ORDER M-4-17
Relating to Certification of New Motor Vehicles

SUZUKI MOTOR CO., LTD.

Pursuant to the authority vested in the Air Resources Board by the Health and Safety Code, Division 26, Part 5, Chapter 2; and

Pursuant to the authority vested in the undersigned by Health and Safety Code Sections 39515 and 39516 and Executive Orders G-45-3 and G-45-4;

IT IS ORDERED AND RESOLVED: That 1983 model-year Suzuki Motor Co., Ltd. exhaust emission control systems are certified as described below for four stroke gasoline-powered motorcycles:

BE IT FURTHER RESOLVED: That pursuant to Executive Order G-70-16-E, motorcycles are exempt from compliance with the Air Resources Board's "Specifications for Fill Pipes and Openings of Motor Vehicle Fuel Tanks."

Vehicles certified under this Executive Order must conform to all applicable California emission regulations.
