## EXECUTIVE ORDER A-242-3 Relating to Certification of New Motor Vehicle Engines

## VOLVO TRUCK CORPORATION

Pursuant to the authority vested in the Air Resources Board by Sections 43100, 43102, and 43103 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-3;

IT IS ORDERED AND RESOLVED: That the following Volvo Truck Corporation 1984 model-year diesel engines have shown compliance with the optional transient standards and are certified for use in motor vehicles with a manufacturer's gross vehicle weight rating greater than 8500 pounds:

The decal shall display the applicable model-year heavy-duty engine exhaust emission standards and the following certification emission values:
