Relating to Certification of New Heavy-Duty Motor Vehicle Engines

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Orders G-45-3;

IT IS ORDERED AND RESOLVED: That the following Ford Motor Company 1988 model-year gasoline engines are certified for use in motor vehicles with a manufacturer's gross vehicle weight rating (GVWR) of 8,501 to 14,000 pounds:
