EXECUTIVE ORDER A-9-6
Relating to Approval of New Motor Vehicles

CHRYSLER CORPORATION

Pursuant to the authority vested in the Air Resources Board by Section 39150 and 39151 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Section 39023 of the Health and Safety Code;

IT IS ORDERED AND RESOLVED: That Chrysler Corporation gasoline powered engines in 1973-model heavy-duty motor vehicles are approved for the engine families described below:

<u>Family</u>	<u>Engine Size CID</u>	<u>Engine Model</u>	<u>Exhaust Emission Control System</u>
RBM	440	440-1	Engine Modification
RBM	440	440-3	Engine Modification

Section 39152, Part I, Division 26 of the California Health and Safety Code requires that the manufacturer affix a decal to the side window to the rear of the driver or, if there is no such window on the driver's side, to the windshield of the motor vehicle.

The following are the recommended values to be listed on the decal:

<u>Engine Family</u>	<u>Hydrocarbons plus Nitrogen Dioxide grams/BHP-hr.</u>	<u>Carbon Monoxide grams/BHP-hr</u>
RBM	15	23
