EXECUTIVE ORDER A-116-6
Relating to Certification of New Motor Vehicles

Pursuant to the authority vested in the Air Resources Board by Health and Safety Code Sections 43100, 43102, 43103, and 43835; and

Pursuant to the authority vested in the undersigned by Health and Safety Code Sections 39515 and 39516 and Executive Orders G-45-3 and G-45-4;

IT IS ORDERED AND RESOLVED: That Specialized Automotive Engineering, Inc. exhaust emission control systems are certified as described below for 1979 model-year gasoline-powered light-duty trucks.



Vehicles certified under this Executive Order must conform to all applicable California emission regulations.
