Do you own off-road diesel vehicles?

The Air Resources Board (ARB) is working on a regulation that could impact your business and cost you money. The proposed In-Use Off-road Diesel Vehicle Regulation would reduce the public's exposure to cancer-causing diesel exhaust and other pollution from diesel vehicles.

The proposed regulation may require you to retrofit, repower, or replace your off-road diesel-fueled vehicles gradually over the next decade. The proposed regulation could require you to take action to begin cleaning up your fleet as early as 2008 and will affect off-road mobile diesel vehicles greater than 25 horsepower, such as loaders, backhoes and others. It will not affect equipment like generators that is towed. Such "portable equipment" is addressed by another program.

ARB is holding public workshops to discuss the proposed regulation in late February and March 2007 in San Diego, Sacramento, Riverside, and Fresno. RE: Proposed Regulation for Off-Road In-Use Diesel-Powered Construction, Mining, Industrial, GSE, and Other Off-Road Diesel Vehicles

Dear Airport Manager:

The purpose of the proposed regulation is to reduce diesel particulate matter (PM) and other emissions from in-use off-road diesel-fueled vehicles (25 horsepower and greater engines) operating in California. It would apply to a wide variety of self-propelled vehicles (the engine provides the motive power) used in construction, mining, industrial operations, and airport ground support equipment (GSE) such as aircraft pushback tugs, baggage and cargo tugs, carts, forklifts and lifts, ground power units, air conditioning units, belt loaders, and other equipment.

The Air Resources Board (ARB or Board) will hold four public workshops to discuss ARB's proposed in-use off-road diesel vehicle regulation. The workshops will be held in February and March. A live internet broadcast (webcast) will be available for the Sacramento workshop. The workshop notice is at http://www.arb.ca.gov/msprog/ordiesel/documents/Revised_Off-Road_Workshop_Notice.pdf

This letter is part of our outreach to provide information that the State Of California is proposing, to which many airports, and airport-related businesses and services, will have to comply. 

Frequently Asked Questions

Proposed In-Use Off-road Diesel Vehicle Regulation

Q: What will the proposed regulation require?

A: If the rule is adopted as proposed, beginning in 2008, anyone who owns off-road diesel vehicles of 25 horsepower or more operating in California will need to report their vehicle information to the Air Resources Board. In later years, they will need to ensure that their fleet of off-road diesel vehicles is clean enough to meet the tailpipe emission targets set by the regulation. If a fleet does not meet the targets, then the owner must gradually take actions to clean the fleet including, installing exhaust retrofits, engine repowers, or replacing vehicles with cleaner new or used vehicles.

Q: Will the regulation apply to me?

A: Owners of diesel-powered construction equipment such as crawler tractors, excavators, loaders, skid steers, backhoes, and diesel mining, industrial or airport ground support equipment such as forklifts will need to comply with the regulation. The regulation applies only to self-propelled vehicles; it does NOT apply to portable equipment such as generators, wood chippers, and pumps. Some equipment with two engines, like cranes, may have an engine subject to this regulation and one subject to the portable equipment regulation.

Q: Will I have to get rid of my vehicle?

A: No, the rule does not require that a vehicle owner sell or otherwise get rid of any particular vehicle, although you may need to repower some older, dirtier engines. To accommodate the wide variety of businesses operating in California, the regulation provides flexibility in how you may choose to comply with the regulation.

Q: How much will it cost me?

A: The cost of complying will depend on your specific fleet of vehicles, your normal business practices, and the strategy you choose to comply with the regulation. To allow you to meet the requirements of the regulation with the least expense, the regulation provides a number of methods to demonstrate compliance. If you normally operate very clean vehicles and regularly purchase new equipment, there may be little cost to comply with the regulation. On the other hand, if you typically operate very old, dirty equipment, your costs could be substantial. However, the ARB designed the regulation to avoid unreasonable costs to less financially robust businesses.

Q: Why is this regulation needed?

A: Diesel exhaust emissions from construction equipment and other diesel engines are a serious health risk responsible for more than 1,000 premature deaths per year in California. People breathing the fumes from diesel engines have an increased risk of asthma, bronchitis, and respiratory and cardiovascular ailments. By cleaning up off-road diesel engines, this regulation will reduce the risk of illness and premature death to Californians.

Attention Owners of Off-Road Diesel Vehicles

The State is Developing a Regulation that Could Affect You

The new rule is aimed at reducing diesel particulate matter and other emissions from **existing off-road diesel engines operating in California.**

The Proposed Regulation Will Affect:

- √ **Diesel off-road vehicles 25 horsepower and up including**
 - construction equipment such as crawler tractors, loaders, skid steers, and backhoes
 - diesel mining, industrial or airport ground support equipment
 - other self-propelled vehicles, like forklifts
- √ Will **NOT** affect equipment used in agricultural operations
- √ Will **NOT** affect equipment like a portable generator that is towed
- √ Will **NOT** affect vehicles and equipment already covered by another regulation or agreement

Key Parts of the Proposed Regulation:

- √ Label each vehicle with an ID number
- √ Report vehicle information to the Air Resources Board
- √ Meet average tailpipe emission targets for your fleet
 - may require installing of exhaust retrofit devices
 - may require accelerated replacement of vehicles or engines



This letter is being sent to you because you have equipment registered with the Air Resources Board's (ARB or Board) statewide portable equipment registration program. This letter is to inform you that ARB is proposing a regulation to reduce diesel particulate matter (PM) and other emissions from in-use off-road diesel-fueled vehicles (25 horsepower and greater engines) operating in California. It would apply to a wide variety of self-propelled vehicles (backhoe, bulldozer, etc) used in construction mining, industrial operations, airport ground support equipment, and other equipment. The proposed regulation will not cover portable equipment (generators, pumps, welders etc), which is already subject to an existing ARB regulation.
