Second Notice of Public Availability of Modified Text and Availability of Additional Document

PUBLIC HEARING TO CONSIDER PROPOSED AMENDMENTS TO THE TABLES OF MAXIMUM INCREMENTAL REACTIVITY VALUES

Public Hearing Date: November 3, 2009 First Public Availability Dates: February 23, 2010 - March 10, 2010 Second Public Availability Date: April 26, 2010 Deadline for Public Comment: May 11, 2010

At a public hearing on November 3, 2009, a delegate of the Air Resources Board's Executive Officer considered amendments to the California Code of Regulations, title 17, sections 94700 and 94701, which consist of Tables of Maximum Incremental Reactivity (MIR) values for volatile organic compounds (VOC) and mixtures of VOC. (Section 94700 was last amended in 2004.) At the hearing, the staff stated that they would propose modifications to the regulations originally proposed in the Staff Report released on September 18, 2009.

The attachment to this notice consists of revised regulations, showing the proposed second "15-day" modifications to the originally proposed regulatory language. Because the originally proposed regulatory amendments used <u>underline</u> to indicate additions to the regulation (and contained no deletions), the proposed modifications that were made available by the first "15-day" notice on February 24, 2010 were shown in <u>bold double underline</u> to indicate additions to the original proposal and double strikeout to indicate deletions. The additional proposed modifications being made available by this second "15-day" notice are shown in <u>single underline italics</u> to indicate additions and single strikeout italics to indicate deletions. Summary of Proposed Modifications

Staff was informed of duplicate entries in the MIR tables for four hydrofluoroethers (HFEs). Staff was also informed that the MIR values provided for the four nonafluoroethers (listed in the tables as compounds #1094, 1095, 1111, 1112) were based on estimation methods that appeared to work very poorly for these HFEs, and that the MIR values provided for the four perfluoro-ethers (listed as compounds #1096, 1097, 1109, 1110) were based on experimentally measured values. In consideration of this new information, staff proposes two modifications to the MIR tables in Attachment A.

- 1) Staff proposes to delete the four nonafluoro-ethers, as follows.
- # Description
- 1094 methyl-nonafluoro-butyl ether; HFE-7100 isomer
- 1095 methyl-nonafluoro-isobutyl ether; HFE-7100 isomer
- 1111 ethyl nonafluorobutyl ether; HFE-7200 isomer
- 1112 ethyl nonafluoroisobutyl ether; HFE-7200 isomer
- 2) Staff proposes to add the nonafluoro-ether and HFE synonyms to the descriptions of the four perfluoro-ethers, as follows, and re-number the table accordingly.
- # Description
- 1096 methoxy-perfluoro-n-butane; <u>methyl-nonafluoro-butyl ether; HFE-7100 isomer</u>
- 1097 methoxy-perfluoro-isobutene; <u>methyl-nonafluoro-isobutyl ether; HFE-7100</u> isomer
- 1109 ethoxy-perfluoro-n-butane; ethyl nonafluorobutyl ether; HFE-7200 isomer)
- 1110 ethoxy-perfluoro-isobutane; ethyl nonafluoroisobutyl ether; HFE-7200 isomer

Supporting Document and Information

In accordance with Government Code section 11347.1, staff has added the following document to the rulemaking record in support of the proposed action: "SAPRC Atmospheric Chemical Mechanisms and VOC Reactivity Scales," by W.P.L. Carter, as revised April 20, 2010, and posted at http://www.cert.ucr.edu/~carter/SAPRC. The following entry in this document supports the proposed modifications as described in this notice:

<u>4/20/10</u>: Duplicate entries of several perfluoro ethers, with incorrect MIR and other reactivity values, have been deleted from the reactivity tabulations in Table B-1 in saprc07.xls and in scales07.xls. The deleted entries, with incorrect reactivity values, were for "methyl-nonafluoro-butyl ether", "methyl-nonafluoro-isobutyl ether", "ethyl nonafluorobutyl ether", and "ethyl nonafluoroisobutyl ether". These are the same compounds as methoxy-perfluoro-n-butane, methoxy-perfluoro-isobutane, ethoxy-perfluoro-n-butane, and ethoxy-perfluoro-isobutane, which are also on the reactivity list but with the correct reactivity values.

Comments and Subsequent Action

In accordance with the Government Code section 11346.8, and as directed by the Board, the Executive Officer shall adopt the amendments to the California Code of Regulations, title 17, sections 94700 and 94701, after making them available to the public for comment for a period of at least fifteen days. The Executive Officer shall consider such written comments as may be submitted during this period, and shall make such modifications as may be appropriate in light of the comments received.

Written comments will only be accepted on the proposed modifications and the additional document being added to the record, and may be submitted by postal mail or electronic mail submittal as follows:
