WHEREAS, Peter has complemented his technical competence with a great sense of humanity, kindness, and ethical behavior. As our valued colleague leaves his post here at ARB, he takes with him the respect of the Board members and staff, regulated industry, environmental advocates, the nationwide air pollution control community, and every Californian that breathes cleaner air;

WHEREAS, Peter has utilized his skills as a trained Porsche race car driver to run the Stationary Source Division with precision;

WHEREAS, Peter now wishes to reinvent himself in his retirement as a gentleman rancher, world traveler, grandfather, retired annuitant, seasoned mechanic/pit crew/race car driver, and man-about-town; and

WHEREAS, Peter is a man who knows how to make the most of any golden opportunity, and that is why we have no doubt that he will enjoy every moment of his life after ARB with his wife Jeannie; daughters Catherine, Laura, and Jean-Marie; and sons-in-law Dean and John.
