Public Workshop on the Preliminary Draft Regulation

Background

The AB 32 Scoping Plan, California's blueprint for reducing greenhouse gas (GHG) emissions, incorporates a range of measures to reduce GHG emissions in California, including the creation of a cap-and-trade program. On November 24, 2009, ARB released a <u>Preliminary Draft Regulation</u> (PDR) for the cap-and-trade system. ARB staff had planned to release the next draft of the regulation by the end of April, 2010, but has decided instead to conduct additional public meetings to describe and get input on staff's current thinking on the program design before releasing additional regulatory language. Staff will present information on the status and plans for the next steps in the program design process in the first part of this workshop.

Adams Secretary for Environmental Protection The Preliminary Draft Regulation provided a conceptual regulatory framework for many areas of the system but left a key area of program design—the allocation of allowances—to be defined in future drafts upon consideration of technical analysis and stakeholder input. The omission of allowance allocation in the PDR allowed for the completion and consideration of the recommendations of an expert advisory committee, known as the Economic and Allocation Advisory Committee (EAAC). The EAAC was created to provide input to ARB on the topics of allowance allocation and economic analysis. The <u>EAAC</u> report on allowance allocation was finalized in March, and an overview of their recommendations was presented at the March 2010 Board hearing.

Since the PDR and the EAAC report were completed, ARB staff has reviewed written comments and has been holding informal discussions with a wide variety of stakeholders. Based on the input received to date, ARB is exploring a variety of options that would allow a smooth transition into the cap-and-trade program in light of the current economic conditions. The ultimate success of AB 32 and of the cap-and-trade program in particular will depend in large part on the ability of all California businesses and residents to invest in energy efficiency and clean energy, and the design of the cap-and-trade program will need to encourage rather than hinder that investment. At this workshop, staff will provide an overview of the options that are currently under consideration.
