Background

Senate Bill 1383 (Lara, Chapter 395, Statutes of 2016) requires CARB to work with a broad range of stakeholders to identify and address technical, market, regulatory, and other challenges and barriers to the development of dairy methane emissions reduction projects. In May 2017, CARB, the California Department of Food and Agriculture, the California Energy Commission, and the California Public Utilities Commission convened a Dairy and Livestock Greenhouse Gas Reduction Working Group (Dairy and Livestock Working Group). Three subgroups were formed at the May 2017 public meeting to develop policy recommendations in the following specific areas: fostering markets for non-digester projects (Subgroup #1); fostering markets for digester projects (Subgroup #2); and research needs, including enteric fermentation (Subgroup #3). The Dairy and Livestock Working Group met again on January 5, 2018, where the Subgroups provided a status on their progress to date as well as interim recommendations. The Subgroups will continue to meet in 2018 and are expected to provide final recommendations to the Dairy and Livestock Working Group before the end of 2018.
