SETTLEMENT AGREEMENT

This Settlement Agreement (Agreement) is entered into by and between the California Air Resources Board (ARB), with its principal office at 1001 I Street, Sacramento, California, and Odif USA (Odif) with its principal place of business at 458 Danbury Road, Unit A18, New Milford, Connecticut.

RECITALS

- 1. Health and Safety Code (H&SC) section 41712 mandates the reduction of volatile organic compounds (VOC) from consumer products. ARB adopted Consumer Product Regulations in phases under title 17, California Code of Regulations (CCR) section 94507, et seq., which includes the Adhesives: Mist Spray category.
- 2. Title 17, CCR, section 94509 (a) specifies that the Consumer Product Regulation applies to any person who sells, supplies, offers for sale, or manufactures for sale in California any consumer product containing VOCs.
- 3. Title 17, CCR, section 94509 (a) sets forth in the Table of Standards the percent by weight for Mist Spray Adhesives sold after January 1, 2002. Mist Spray Adhesives must meet the 65 percent standard.
- 4. Title 17, CCR, section 94512(a) sets forth labeling requirements for aerosol adhesives which requires that the VOC category and category limit be placed on the label of each aerosol adhesive.
- 5. Failure to comply with the Consumer Products Regulation is a violation of State Law resulting in penalties. Among other penalties, H&SC sections 42400-42403 authorize strict liability penalties up to \$10,000.00 for each day that the violation occurs.
- 6. ARB alleges that Odif sold, supplied, and offered for sale in California, 505 Spray and Fix, which is subject to the VOC limit for the Adhesives: Mist Spray category in title 17, CCR, section 94509 (a).
- 7. ARB alleges that the 505 Spray and Fix referenced in Recital paragraph 6 did not display the VOC category and category limit on the label as specified in title 17, CCR, section 94512(a).
- 8. ARB alleges that if the allegation described in recital paragraph 7 were proven, civil penalties could be imposed against Odif as provided in H&SC sections 42402, et seq. for each and every unit involved in the violations.
- 9. Odif admits the allegations described in recital paragraphs 7, but denies any liability resulting from said allegations.

10. In consideration of the foregoing, and of the promises and facts set forth herein, the Parties desire to settle and resolve all claims, disputes, and obligations relating to the above-listed alleged violation and voluntarily agree to resolve this matter by means of this Agreement, without the need for formal litigation. Odif has taken, or agrees to take, the actions enumerated below within the Terms and Conditions. ARB accepts this Agreement in termination and settlement of this matter.

TERMS AND CONDITIONS

In consideration of ARB not filing a legal action against Odif for the violations referred to above, ARB and Odif agree as follows:

- 11. Odif shall not manufacture, sell, supply or offer for sale for use in California any consumer products in violation of ARB consumer products regulations set forth in title 17, CCR, section 94500 et seq.; the terms and conditions set forth in this agreement will remain valid and enforceable notwithstanding any future violations that may occur.
- 12. Odif in settlement of the above-described violations of title17, CCR, section 94509(a) agrees to pay a penalty to ARB in the amount of \$3000.00 payable to the California Air Pollution Control Fund, concurrent with the execution of this Agreement. Payment and the signed Agreement shall be mailed to the address specified in the Payment Transmittal Form attached to this Agreement.
- 13. This Agreement shall apply to and be binding upon Odif and its officers, directors, receivers, trustees, employees, successors and assignees, subsidiary and parent corporations and upon ARB and any successor agency that may have responsibility for and jurisdiction over the subject matter of this settlement.
- 14. The parties stipulate that this Agreement shall be the final resolution of ARB claims regarding the above-described violations and shall have the same res judicata effect as a judgment in terms of acting as a bar to any civil action by ARB against Odif, its officers, directors, receivers, trustees, employees, successors and assignees, subsidiary and parent corporations. This Agreement shall be deemed the recovery of civil penalties for purposes of precluding subsequent criminal action as provided in H&SC section 42400.7(a).
- 15. This Agreement shall be interpreted and enforced in accordance with the laws of the State of California, without regard to California's choice of law rules.
- 16. This Agreement constitutes the entire agreement and understanding between ARB and Odif concerning the claims and settlement in this Agreement, and this Agreement fully supersedes and replaces any and all prior negotiations and agreement of any kind or nature, whether written or oral, between the ARB and Odif concerning these claims.

- 17. The Effective Date of this Agreement shall be the date upon which it is fully executed.
- 18. This Agreement is deemed to have been drafted equally by ARB and Odif; it will not be interpreted for or against either Party on the ground that said Party drafted it.
- 19. No agreement to modify, amend, extend, supersede, terminate, or discharge this Agreement, or any portion thereof, shall be valid or enforceable unless it is in writing and signed by all parties to this Agreement.
- 20. This Agreement shall further serve to toll any statute of limitation until all terms and conditions of this Agreement have been fulfilled.
- 21.**1402 Statement**. HSC section 39619.7 (Senate Bill 1402 Dutton, Chapter 413, statutes of 2010) requires ARB to provide information on the basis for the penalties it seeks. This Agreement includes this information, which is also summarized here.

The provision of law the penalty is being assessed under and why that provision is most appropriate for that violation.

The penalty provision being applied in this case is HSC section 42402, et seq. because Odif sold, supplied, offered for sale, or manufactured for sale consumer products for commerce in California in violation of the Consumer Products Regulations (title 17, CCR, section 94507, et seq.). The penalty provisions of HSC section 42402, et seq. apply to violations of the Consumer Products Regulations because the regulations were adopted under authority of HSC section 41712 which is in Part 4 of Division 26 of the HSC.

The manner in which the penalty amount was determined, including aggravating and mitigating factors and per unit or per vehicle basis for the penalty.

HSC section 42402, et seq. provides \$1,000 per day penalties for strict liability violations of the Consumer Products Regulations, with each day being a separate violation. In cases like this, involving unintentional violations of the Consumer Products Regulations where there is an administrative penalty and the violator cooperates with the investigation, the ARB has obtained penalties based on at least three days of violations (the day the product was purchased by ARB, the day it was supplied to the retailer, and the day it was manufactured for sale).

In this case the total penalty is \$3,000. The penalty in this case was reduced because this was a strict liability first time violation and Odif made diligent efforts to comply and to cooperate with the investigation. Penalties in future cases might be higher or lower on a per ton or per day basis.

Is the penalty being assessed under a provision of law that prohibits the emission of pollution at a specified level, and, if so a quantification of excess emissions, if it is practicable to do so.

The Consumer Product Regulations do not prohibit emissions above a specified level, but they do limit the concentration of VOCs in regulated products. In this case a quantification of the excess emissions attributable to the violations was not necessary.

- 22. Each provision of this Agreement is severable, and in the event that any provision of this Agreement is held to be illegal, invalid, or unenforceable in any jurisdiction, the remainder of this Agreement remains in full force and effect.
- 23. The undersigned represent that they have full power and authority to enter into this Agreement.
