Comment:

I am grateful that the State has passed SB 375, which improves everyone's quality of life through improved transportation planning that reduces air pollution and greenhouse gas emissions.

MPOs are proposing to reduced air pollution and greenhouse gas emissions through reducing vehicle miles traveled VMT per person.

VMT reductions can produced many benefits:

- Reduce traffic congestion
- Reduce consumption of gasoline
- Reduce our dependence on foreign oil.
- Encourage improve access to transit through better land development that will be more walkable and bikable
- Such developments also provides job opportunities, shopping and other amenities closer to residences
- Plus reduce air pollution and greenhouse gas emissions providing a more healthful environment and reduce the impending environmental disasters

However, the VMT reductions per capita that the MPOs and CARB have proposed are limited to accomplish all these benefits, because of projected population increases. In other words, the net result from even the maximum proposed 10% VMT reduction per capita still means an 8% increase in VMT by 2020, considering the population increase and a 5% VMT target would mean a 14% increase. By 2035, a 12% VMT reduction per capita would mean the total VMT would 28% higher than in 2005 (using the official California Dept of Finance population projections).

To accomplish the needed reductions requires stopping sprawl and shifting to in-fill development along with ending highway expansion. Transportation planning must include aggressive coordinated land planning and transportation demand management that supports increased transit use, car-pooling, bicycling and walking, unbundling parking costs, pricing of roadway use and parking pricing

As a past SF BART Director and Member of TRB's Committee on Transit Development and Land Use, our current pricing system on BART transit parking is fundamentally unfair especially because its improvement cost and the increased land value occupied by parking is equivalent to \$6-7 per space, yet the charge if any is applied is a fraction of this cost, so non-parkers who are less affluent and more transit dependent subsidize the more affluent suburbanite use of BART parking. In turn peak hour feeder transit subsidized at the same cost as the parking subsidy is seldom used and where BART

could in lieu develop Transit Oriented Development on the acres of space occupied by parking or costly structured parking.

Being revenue neutral and driving less will reduce VMT. I believe that the combination of land use change and ending highway expansion will put California on track to achieve a 2035 target of no net total increase in VMT.

I know that the MPO draft targets are challenging because they represent a reversal of the historic trend in constantly relieving congestion and increasing VMT per capita. But the bottom line is these measures will expand local jobs opportunities and improve the quality of life in all our communities as well as impending environmental disasters.

We sent you earlier comments on these draft emission reduction target and the methodology used to develop them. We continue to believe that adopting per capita based emission reduction goals is a recipe for increasing each region's overall air pollution and emission levels, since projected growth in population will more than offset any reductions achieved on a per capita basis. If CARB still insists on adopting per capita goals in order to facilitate comparisons between regions, we strongly urge you to also adopt absolute net GHG reduction goals for each region. It will do us no good if each person is reducing their GHG emissions, if the size of the population in each region is growing at a pace that creates a net increase in GHG emissions each year. Each region should also have overall net GHG reduction goals that take into account population growth to ensure that we are actually meeting the mandates of SB 375. CARB should not undercut the goals of AB 32 and SB375 by only setting per capita goals for each region. That would leave CARB open to lawsuits for failing to implement the laws as written.

Dear ARB Board:

Please give some attention to the proposed GHG Reduction Targets for the AMBAG region. This needs your attention in part, because the target drafting process appears to have suffered from, at least, a lack of focus on this "smaller" region of 3/4 million people, if not an outright breakdown of the drafting process.

After the ARB's August 9 staff report came out with proposed targets of +13% (increase!) by 2020 and +14% by 2035, AMBAG staff and other public officials told me they were surprised, or shocked, by these non-reduction targets. ARB staff told me they issued targets based on AMBAG's previous 2008 business-as-usual (no action on GHG) forecast, on the rather slight explanation that AMBAG did not submit a specifically endorsed single set of proposed targets to ARB. Apparently, the hard working ARB staff ran out of capacity before it came to working further with the less prominent AMBAG region, to devise better.

Then, once the proposed "do-nothing" targets were out, some local officials, including on the AMBAG Board, were understandably confused, imagining incorrectly that the targets were based on a healthy collaborative and scientific process and little better could be advised.

In an attempt to address the unacceptable situation, at AMBAG's special meeting regarding GHG Reduction Targets on August 23, 2010, at which I was present, the AMBAG Board voted 16 yes to 6 no, to endorse targets of 0% by 2020 and -5% reduction by 2035. AMBAG staff's presentation at the meeting, also advised the Board that more ambitious targets of -5% by 2020 and -10% by 2035, are a supportable option the AMBAG Board could also consider.

Besides AMBAG staff's anticipation of further modeling results in the near future to support yet much better targets, it is also quite safe to say that there is nothing uniquely disadvantaged with the circumstances of our three-county region, that we can't plan to do as much or better than other MPO regions.

AMBAG staff's memo to the AMBAG Board correctly observes that "there is substantial public expectation that this region will seek to be a leader in GHG reductions from the transportation sector."

If there is some doubt here, I suggest you use the instruction and clear intent of state law, AB 32 and SB 375, as your guide. Your

job in this instance as public servants, I believe, is to help humanity avoid future climate catastrophe. The climate scientists are telling us we must act now, not later. The ultimate economic penalties will be incurred, if we do not.

I urge you to adopt targets of -5% and -10% for the AMBAG region, which AMBAG staff presented as an option, and which will spur a little healthy innovation to achieve. Or, at the very least, to adopt the 0% and -%5 targets which a large majority of the AMBAG Board endorsed on August 23.

Here is the conclusion of the attached letter to the ARB:

Targets will have to be more stringent than the AB 32 and S-3-05 target trajectories if we are going to fulfill our world leadership responsibility and give the world a chance at avoiding climate destabilization. The 2020 Target of -7% (per-capita from VMT) can only result in an AB 32 level reduction if both "Pavley" and the LCFS factors are used. The 2035 reduction target of -13% would have to instead be 35.15%, to just meet the straight-line trajectory of S-3-05 for 2035, and this is assuming the Pavley reductions continue on the "Pavley 1" trajectory all the way to 2035. This assumption about "Pavley" may be overly optimistic. The science-supported 2035 reduction is 45%.

The best, largely overlooked strategies to reduce VMT are a comprehensive and variable road use fee pricing system, as is being installed by Skymeter; unbundling the cost of car parking; good bicycle projects and bicycle education; putting a stop to all freeway expansions; and reconfiguring sales taxes for freeways or freeway/transit combinations to instead be 100% for transit. These strategies could easily be implemented by 2020 and would easily decrease driving by a sum of at least 45%. The strategies to do this are primarily those that increase fairness for families that drive less than average.

Given this set of conclusions, it is clear that the reductions proposed for SANDAG are neither just nor reasonable. By extension, this is true for the reductions proposed for the other MPOs.

On behalf of a wide variety of business, labor and community interests – including the California Building Industry Association, National Federation of Independent Business- CA, and many others – we would like to ask for your help on an urgent matter. The California Air Resources Board has proposed greenhouse gas emission reduction targets under SB 375 that are extremely restrictive, and ultimately impossible to meet. The targets would result in massive cost increases for the average family and small businesses, would place huge financial and infrastructure burdens on local governments, and would open the business community to unbearable lawsuits and restrictions on development. Experts at regional planning organizations have forecasted that these high regulations will result in negative impacts that will harm our state's residents and our economic recovery – for example:

- \$9.07 per gallon gas prices
- Congestion fees in metropolitan areas
- Taxes on vehicle miles traveled (VMT)
- Parking fee increases in local municipalities
- Relocation of 200,000 people into the city centers.

#### What Happened?

After a series of public workshops focusing on setting realistic targets for greenhouse gas emission reduction, the California Air Resources Board (CARB) staff unexpectedly proposed unreasonable and unachievable targets that will impede economic recovery and impose major financial burdens on local communities. During the stakeholder process, the Metropolitan Transportation Commission (MTC), the planning, coordinating and financing agency for the nine-county San Francisco Bay Area, stated that they could achieve a 5% reduction in 2020 and 5% reduction in 2035. However, CARB's recommendation set more extreme target levels of 7% for 2020 and 15% for 2035. Similarly, the Southern California Association of Governments (SCAG), which is the metropolitan planning organization representing six counties, 190 cities and more than 19 million residents, recommended a realistic target range of 6-8% for 2020 and 3-6% for 2035. But CARB set the Southern California levels at 8% for 2020 and 13% for 2035.

#### Major Economic and Lifestyle Impacts

- Consumer costs. According to the MTC's professional staff evaluation of Bay Area impacts, the extreme targets proposed by CARB would result in massive price increases for families and businesses.
- Increased gas prices: The MTC concluded that even a target of 12% (let alone 15%) would require gas prices of \$9.07 per gallon to encourage less driving.
- Congestion tax: The MTC would have to institute congestion fee pricing of \$0.25 per mile for using freeways during peak periods - resulting in a 460% annual increase to travel costs.
- Parking fee increases: Parking costs across the state would be increased by \$1.00 per hour.
- Overall, CARB's targets would increase auto operation costs by five-fold.
- Population relocation. CARB's targets would force people to abandon suburban life-styles and move into city centers with higher population density. The MTC projected moving 200,000 people out of the suburbs and into the city center to meet the targets.
- Lack of funding. Local governments simply do not have the funding to support the infrastructure needs nor the planning activities that would be required under the targets. Already local governments have to cut budgets and reduce public transit service - there is no guaranteed additional funding to support the new transit needs that would be necessary to meet the targets.
- Potential loss of federal funds. The unrealistic regional planning processes required under the SB 375 could likely result in the additional loss of federal transportation funding for

local governments.

- Faulty assumptions. CARB's emission reduction targets rely on the fruition of future high-cost transportation projects that are still in early development phases. Without these projects, the targets are even further out of reach. These projects include high speed rail, high occupancy lanes, toll roads, etc.

#### Preventing Economic Growth, Creating Uncertainty

- Counting on a poor economy. The GHG reduction targets rely on a poor economy and lower jobs as a tool for meeting their strict emission reductions. According to MTC's analysis, forecasting and planning for fewer jobs and less economic growth could result in 5% emission reductions
- Uncertain regulatory process. CARB has released targets that are unreasonable, but has established an alternative process to re-evaluate these targets. This uncertainty over the targets is detrimental because businesses need certainty and clarity in the regulatory requirements in order to support investment decisions regarding location, expansion and operation.
- More lawsuits. The infeasible targets could be used to justify even more lawsuits designed to stop any new development. With extreme emission reduction requirements, businesses will be forced to pay huge fines, implement expensive and unreasonable mitigations, and possibly face lawsuits that could stop their development altogether if it is determined to be too far outside the city center.
- Preserving the recession. Unreasonable restrictions on development, construction and home building will prevent our economy from rebounding and harm efforts to reduce the state's high unemployment numbers.

#### Flawed Process

SB 375 was passed in 2008 to address regional planning for transportation, housing and greenhouse gasses. CARB set forth on a collaborative process that engaged officials at the local level to identify emission reduction targets associated with land use and transportation that are both ambitious and achievable. Regional Metropolitan Planning Organizations (MPOs) were in charge of recommending emission reduction targets that they forecasted to meet the goals of SB 375. However, CARB staff disregarded the input and analysis provided during the stakeholder process, and instead have proposed completely unrealistic reduction targets that were not even discussed or modeled.

- Targets not evaluated. The SB 375 process included numerous public workshops to examine emission reduction targets that would be both ambitious and reasonable for local governments. The MPOs evaluated target ranges, and determined that the aggressive targets being explored were overly ambitious and simply not achievable. However, CARB's targets were even higher than the most aggressive options mentioned in the workshops.

- o In Northern California, the Metropolitan Transportation Commission (MTC) modeled their most aggressive target at 12% GHG reduction by 2035. The MTC highlighted that the most aggressive targets are "not considered attainable by any stretch of the imagination." Despite this warning, CARB's suggested target for the Bay Area is 15% by 2035
- o The Southern California Association of Governments suggested that a GHG reduction of 5 or 6% by 2035 is attainable. They forecasted that GHG reductions above 10% by 2035 are considered too ambitious and unattainable. However, CARB's suggested target for the region is set at 13% by 2035.
- No basis for last minute change. There is no explanation as to why CARB moved way beyond the targets discussed in the workshops. They ignored public input and expert testimony, and adopted extreme targets that were never vetted in the public process.
- Ignores realistic human costs. Each incremental percentage reduction for emissions is exponential. Therefore each percentage increase in the targets requires huge behavior changes and skyrocketing costs.

Scoping Plan is quantitatively ONLY about AB32. AB32 only goes out  
to 2020. The 2008 Scoping Plan does NOT support the 15 MMTCO<sub>2</sub>  
value  
for 2035.

Nothing does.

So I have these 4 questions. What about 2035? What about the  
Governor's Executive Order? What about climate stability?

My calculations indicate that a much larger reduction is required  
by 2035, as follows.

1.) Just to show how far off CARB targets are, for 2035, I will  
use  
a "huge" 20% reduction, to result in a 2005 to 2035 factor of .8.

2.) I will use the SANDAG populations figures, which is a growth of from 3034388 to 3984753, for a factor of (the larger over the smaller) 1.313.

3.) Using the values from the above-mentioned Figure 1, the Pavley reduction, extrapolated out to 2035, give a very nice reduction factor of .685.

4.) The LCFS factor is .9.

5.) Using the values from the above-mentioned Figure 1, the straight-line trajectory of the reduction needed to get and 80% reduction by 2050 is .525.

The four factors are multiplied to give  $(.8)(1.313)(.685)(.90) = .648$ . This is not good enough. We need this to be at least as low as .525.

A reduction of 35.1% will do the trick:  $(.649)(1.313)(.685)(.9) = .525$

Please let me know what is wrong with these calculations. If they are correct, the ARB Directors must not approve your 2035 reductions. They are way too small.

I understand that the Air Resources Board will set the SB 375 regional targets during this Thursday's hearing. I am writing to encourage ARB to adopt the staff recommended targets for 2020 and 2035.

From my work on the Strategic Growth Council, I am increasingly convinced that California must make more efficient use of our limited finances and natural resources by making more sound investment decisions. SB 375 can help us accomplish these goals if it is effectively implemented. The regional targets are a vital step in that process. While the staff recommendations represent a compromise, they are sufficient to begin the process of providing greater incentives to local and regional agencies to invest public transportation funds to grow communities in more efficient ways.

It is with the conservation of California's native natural heritage as our highest priority that I must oppose the inclusion of the Climate Action Reserve's forest project protocol as part of AB 32, unless ARB makes the substantial revisions necessary to address the threats the forest protocol poses to forest ecosystems and wildlife habitat.

At their August 31 board meeting, the Climate Action Reserve adopted revisions to the forest protocol. At that time, Climate Action Reserve president Gary Gero announced that his discussions with the Air Resources Board led him to expect that ARB would consider adopting the revised protocol for use in the AB 32 cap-and-trade program, without further revising the protocol.

I need to make it very clear that the recent revisions adopted by the Climate Action Reserve do not address the outstanding concerns about the environmental impacts of the Climate Actions Reserve's forest protocol, and do not address the critical flaws that were previously identified by ARB in their review of the protocol. Thus, ARB must substantially revise the Climate Action Reserve forest protocol before it can be incorporated into any AB 32 compliance mechanism.

Many individuals and organizations have been advocating for more than a year for revisions to address the concerns raised by the forest protocol's inclusion of forest clearcutting as a carbon offset project, and the related threats to forest ecosystems and wildlife habitat. When these concerns were raised in September 2009, the Climate Action Reserve board promised to address these issues on an expedited basis. That never happened. Instead, they undertook other revisions, in some cases exacerbating these concerns. Under the Climate Action Reserve's forest protocol:

- Forest clearcutting and other even-age management practices that degrade forest ecosystems and wildlife habitat can qualify as carbon offset projects;
- Forest offset projects may include timber operations that convert native forest to even-age plantations;
- Forest offset projects may clearcut an entire watershed on a 50-year rotation, with 40-acre clearcuts implemented at 5-year intervals;
- Forest offset projects may claim carbon credits for the growth of trees regenerating after forest clearcutting that occurred at least ten years prior;
- Many forest projects do not have to account for losses from the

understory, litter and soil, and dead wood carbon pools;

- Many forest projects do not have to account for losses of lying dead wood, which can be both a significant carbon pool and a critical component of wildlife habitat;
- Forest offset projects are not prohibited from shifting timber harvesting to elsewhere in their timber operations, and are not even required to report such "leakage."

Unfortunately, the recent revisions fail to address these concerns, and the Climate Action Reserve announced that they do not expect to turn to these issues until next year at the earliest, after the Air Resources Board considers the current version for use under AB 32. This is particularly frustrating since the Reserve, at the request of representatives of the timber industry, expedited the development and adoption of revisions that will allow timber operators to claim credit for forest growth that is already planned to occur under business-as-usual operations.

The forest protocol in its current form is inadequate for use by ARB, as the inclusion of forest clearcutting directly contradicts AB 32's requirement to maximize the environmental benefits from a carbon market program. Forest clearcutting and the conversion of native forests to tree plantations pose the greatest risk to the climate, while simultaneously degrading forest ecosystems, water quality, and wildlife habitat, and impairing the forest's resilience to the impacts of climate change.

I strongly urge the Air Resources Board to make the changes necessary to ensure that the forest protocol meets the substantive requirements of AB 32 and does not incentivize forest clearcutting and other timber practices that threaten forest ecosystems and habitats.

Thank you for your efforts to implement SB 375, California's Sustainable Communities and Climate Protection Act. If implemented properly, SB 375 can result in communities that are sustainable, equitable, and healthier. The United States Air Force (AF) Regional Environmental Coordinator (REC) for Federal Region 9 has been monitoring the implementation of California Senate Bill (SB) 375 and the pending adoption of regional transportation greenhouse gas (GHG) reduction targets by the Board. The AF REC recognizes the benefits of reductions in vehicle miles traveled (VMT) and corresponding GHG reductions. The potential benefits could include opportunities to minimize future impacts generated by urban sprawl on military testing and training missions, retaining efficient transportation access to military installations, and providing enhanced quality of life for military families through transportation demand management (TDM) and transportation system management (TSM) measures. Some California installations have initiated voluntary TDM and TSM projects in cooperation with Metropolitan Planning Organizations (MPOs).

The AF REC supports the adoption of the staff recommendation for regional targets as reasonable goals which both comply with the requirement of SB 375 and provide the potential for producing benefits for continued military operations within the state.

Executive Order 13514 requires Federal agencies to establish GHG reduction strategies, including for Tier 3 emissions which include employee commuting. EO 13514 also directs Federal agencies to engage in regional transportation planning processes. As a volunteer who has spent the last several years working on transportation equity issues, I must object to your proposed reduction goals. While admirable, the goal you have proposed does not consider the unintended consequences and could, in fact, cripple local economies and ruin families financially. It took us decades to get to this place; it shouldn't take decades to fix our emissions, but it cannot be done without careful coordination.

I am involved in local and regional long term planning efforts, so my comments are not just a knee jerk reaction. I am a former Planning Commissioner for the City of San Jose, have worked on Redevelopment projects for over a decade, focusing on disadvantaged neighborhoods. I've sat on any number of local planning committees related to planning, land use and transportation. I sit on the Metropolitan Transportation Commission's Policy Advisory Committee and chaired the equity analysis committee.

I know that local and regional bodies have worked hard to coordinate long term land use and transportation measures. Implementation of policy is dependant upon funding. Unless you can provide the funding to speed up this process, implementing excessive target goals will simply create problems the local agencies cannot handle.

We cannot just assume that we can, for instance, push people from the suburbs into urban settings as a means of reducing road emissions. The urban centers are in a delicate balancing act of planning for increased long term growth while preserving, maintaining and enhancing existing infrastructure. Local transit agencies are not funded to take on a rapid shift in ridership.

The economic reality is it can't be done. Not at this point in time.

I strongly, strongly, strongly urge you to reconsider your target goals and reduce them to the levels recommended by MTC and other regional bodies. They have arrived at their numbers by consulting with local bodies and working with hundreds of interested residents, businesses and non-profits. They have not simply made up numbers, their numbers reflect a great deal of work from staff around the region and also, by the way, from volunteers like me.

Please act on the information gathered and compiled. Please respect the goals set by MTC and other agencies. They are reasonable and achievable goals based on existing infrastructure, and the long term planning and policy process that will allow us to reduce emissions while still growing as projected.

Unless you plan on financing the upgrade, installation or expansion of our transit network, it is irresponsible to attempt to impose goals that can't be met.
