What I never see addressed by CARB is the use of allergy-friendly plants to mitigate roadway air pollution.

As you know, there is a dangerous 300 yard "pollution zone" next to major highways, freeways; people who live in this zone suffer increases in dementia, autism, allergy, asthma, and heart disease. To mitigate some, or much, of this roadway pollution, plants can be used effectively; however, all plants are not equally valuable for this effort. It makes no sense to use plants already known to trigger pollen allergies and allergic asthma. Likewise it doesn't make much sense to use known BVOC producers.

The use of allergy-friendly plants, and of the OPALS plant-allergy scale for selection, has been included in the State of California Public Health's 7 year Plan for Asthma. CARB should start to address this, and to fund it.

The California Department of General Services (DGS) has reached agreement on a set of model contract terms with the Lawrence Livermore National Laboratory, Lawrence Berkeley National Laboratory, and the Sandia National Laboratories. These model contract terms have been approved by the national laboratories and by the DGS Office of Legal Services. They are intended to facilitate contracting between State agencies and these National Laboratories. As explained on the DGS website, the model terms are not required to be used when contracting with the labs; however they should be used as a starting point because they have been pre-approved by the National Laboratories and by OLS and will help simplify the process. If CARB needs to access the unique research and development capabilities of the California-based National Laboratories for any of its projects, it should plan to do so using the DGS-approved template contract, including advanced funding.. This will greatly streamline the process.
