I had to hold my sweater over my nostrils in order to proceed to get the paper.

This phenonomen, to one degree or another, is fairly common, and very unwelcome. (We live 1 mile So. of the airport). I now suffer from asthma, something which has afflicted me since the volume of aircraft at the airport has steadily increased.

Questions:

- . Whom from this agency monitors such emissions?
- . How do I find out the status of pollution emissions from this airport, and how they relate to required standards?
- . The airport is due to present itself at a State Variance hearing soon. Is anyone from this agency assigned to present the pollution problem and situation at this hearing? Obviously, this is needed.
