I have just seen the new report on Recommendations to Implement Further Locomotive and Railyard Emmissions Reductions, and this is also a very important report like The Technical Options Report was.

It will be very important to acheiving major new locomotive greenhouse gas and diesel pollution reductions to change federal regulations to allow California to implement tougher standards. And we should create an organization to do this that includes other state agencies of California, other states that are also adversely impacted by pollution from line haul locomotives, local air resources boards, and others to work to get the laws changed. But while thisis going on, there needs to be an incentive system for the railroads to update their locomotives and railyards. It will take both incentives and law changes. There maybe some additional grants that can help beyond the major oneslisted in the report. The Federal Railroad Administration may have some and the Port of Los Angeles when they made the deal with the manufacturer of the all-electric powered drayage trucks for 25 more trucks and the manufacturing plant set up in the City of Los Angeles also included aprovision that so much money from each truck sold or least here and internationally would go to the Port of Los Angeles as one of its funding sources for environmental programs. One of the Port's goals is cleaner line haul locomotives operating on its property. So this could be another sourceof funding to clean up line haul and switch locomotives as proposed in the recommendations. I am also glad that ARB is still interested in the hydrogen power switch locomotive of BNSF because the only exhaust from hydrogen is pure water vapor. The work on improving diesel engines to make them as clean as possible is something that can be done now as an intermidiate step to hydrogen power. Electric power is also an important key to reducing railyard pollution. Electrifying the rail lines in the Southcoast Air Basin will be a majo help so will a maglev line that connects the ports to near dockintermodal railroad facilities. Subject: Diesel Emission and Cancer Risk Reductions from Locomotives and Rail Yards

Chairwoman Nichols and Board Members:

As physicians and health advocate members of Physicians for Social Responsibility-Los Angeles, we support policies and programs that improve air quality and reduce health disparities for communities in California. Thus, we are asking you to take action now to reduce emissions from rail-yards and locomotives in California by implementing cost-effective, health-protective measures.

We see the adverse health impacts associated with exposure to poor air quality, specifically diesel emissions, on a daily basis in our practices. Premature death, elevated cancer and heart disease risks, respiratory illnesses, adverse birth outcomes, and effects on the immune system are some of the results of this pollution.

In 2008 the California Air Resources Board (CARB) completed Health Risk Assessments (HRAs) for 18 rail yards in the state of California. The HRAs demonstrated that these rail yards pose an unacceptable level of diesel exposure to California residents. In total, these rail yards are responsible for 210 tons of diesel pollution a year. In the city of Commerce alone the assessment revealed that the four BNSF rail-yards emitted 40 tons of toxic air contaminants a year in 2005, while the Union Pacific rail-yard in Commerce emitted 11 tons. The CARB's assessment further indicated that statewide, rail-yard pollution puts 2.8 million residents in California at greater risk of cancer.

Since the release of the HRAs, the state has developed mitigation plans which target diesel emission reductions. Unfortunately, these plans fall short in protecting the community's health.

As health professionals we strongly urge the California Air Resources Board to keep their promise to reduce exposure to harmful pollution for all Californians and implement the following diesel emission reduction recommendations:

1. Create "no idle" zones for locomotives near schools, parks and residential areas.
2. Create health protective buffers between sensitive receptors and the facilities.
3. Provide filtration systems to areas of high health risk.
4. Enforce the use of alternative fuel for locomotives and other

emission source equipment and use the latest, newest emission reduction technologies.

All California communities deserve to breathe air that is healthy and free from toxic air pollutants. Implementing the strongest possible rail yard and locomotive emission reduction measures will go a long way in making this possible.

On behalf of FuturePorts, I want to express my appreciation for the opportunity to comment on the ARB staff's Draft Recommendations to Implement Further Locomotive and Railyard Emission Reductions ("the Recommendations") being presented to the Board Members at the ARB board meeting on September 25th.

Representing a broad spectrum of the businesses in the Southern California goods movement supply chain, FuturePorts recognizes the San Pedro Bay Ports as regional assets, and advocates for balance between economic growth and environmental stewardship.

FuturePorts urges Board to maintain the efficiency of the goods movement system by implementing ARB staff's recommendation to pursue an incentive program to maximize the emissions reductions from locomotives throughout the state. Transporting goods by rail yields criteria pollutant emission benefits, reduces GHGs, and improves freeway congestion for certain key moves as a part of the goods movement system. Operational impacts on one piece of the system can cause disruption to the associated ship, rail, and truck operations throughout California. It is imperative that any action by ARB preserves the efficiency of the system as a whole, and further reduce emissions within that context.

ARB and the San Pedro Ports have had significant success with incentive programs to reduce emissions in partnership with international trade industries. Pursuing the incentive program will allow ARB to achieve their goal of reducing DPM from goods movement sources 85% by 2020. Full implementation of the proposed locomotive measures in the staff's Recommendations "translates to a 65 percent reduction in potential cancer risks in communities surrounding railyards by 2015 and 85 percent reduction by 2020" (Page ES-3).

Right now, in Southern California, the unemployment rate is soaring and thousands of people are looking for work. International trade is a vital economic engine in California and must be allowed to thrive, especially in tough economic times. California must seek methods - like this incentive program - to preserve competitiveness and efficiency of the goods movement system, while driving down emissions in California.
