Attached please find the comment of Gevo regarding the Scenario Concepts Technical Workshop. In particular, the comment draws attention to what appears to be a shortfall in the modeling framework: the lack of recognition of the vast potential for the agricultural sector to sequester carbon in soil. The comment recommends that CARB review the modeling on this specific point, and, in the event that soil carbon is overlooked or minimized, make necessary improvements to the modeling approach. Through recognition of the potential CO2 reduction opportunities that soil sequestration presents, CARB will facilitate achievement of California's goal of carbon neutrality by 2045. Gevo and other low carbon fuel industry leaders are already sourcing feedstocks from low carbon farms to produce fuels but there is great potential to expand these activities.

Comment:

California Forestry Association's comments are focused on the impact of the 2020 and 2021 wildfires in CA and the opportunity for restoration by providing power purchase agreements for idle biomass powerplants (DG Fairhaven, Blue Lake, Loyaltan, Mt. Lassen Power, Oroville, Buena Vista, Madera, Dinuba, Delano and Mendota). These plants can produce about 200 MW when the State needs the power (hydroelectric shutdown due to lake levels too low to run the generators).

The 2020/2021 wildfires in CA caused high severity burn on about 1 million acres. If these acres were restored, they would generate about 5 million bone dry tons of forest biomass. As the Forest Service and State move toward 1 million acres/year of fuels reduction, millions of Bone Dry Tons of additional forest biomass will be produced. 200 MW of additional power could consume about 1.6 million bone dry tons of forest biomass per year. The CPUC was recently seeking new opportunities for additional MWs that can be developed new or at existing facilities by next year. Idle Biomass power plants can be part of the solution.

Forest biomass continues to be an eligible renewable resource that helps balance the grid. Consuming biomass at a powerplant and generating electricity is a reasonable option compared to leaving the forest biomass in the forest to decay and release methane along with the carbon dioxide.

Other than 3 BioRam biomass powerplants, none of the other biomass power plants have power purchase agreements at a high enough rate to cut, skid, pile, chip, load and haul the forest biomass to a powerplant economically.

An infusion of funding would be needed along with reasonable power purchase agreements to incentivize utilization of forest biomass.

The International Emissions Trading Association (IETA) welcomes this opportunity to submit feedback to the California Air Resources Board (CARB) on the 17 August 2021 workshop "2022 Scoping Plan Update - Scenario Concepts Technical Workshop."

As the leading international business voice on climate markets and finance, IETA's non-profit organization represents over 180 companies, including many facing climate risks and opportunities across California. IETA's market expertise is regularly called upon to inform market-based policies that deliver measurable greenhouse gas reductions and removals, address economic competitiveness concerns and balance economic efficiencies with social equity and co-benefits. Our mission is to support broad and functional carbon markets, guided by the principles of efficient, low-cost, measurable climate outcomes while ensuring environmental integrity.

As stated in our 8 July 2021 letter, IETA recommends that CARB's 2022 Scoping Plan explicitly model a cap-and-trade scenario with caps declining to net zero by 2045. This scenario, further outlined in IETA's 2020 Paper "Achieving Carbon Neutrality in California", would center cap-and-trade as the "workhorse" measure and strategy for achieving most of the abatement required to achieve carbon neutrality in California. If CARB does not consider cap-and-trade to be this cornerstone measure, it relegates the state to choosing from a suite of second-best, less efficient options. This would unnecessarily increase California consumer costs and ultimately lower the probability of measurably achieving carbon neutrality. Continued reliance on alternative direct policies would also forego opportunities that higher allowance prices afford, including more revenue for the State to spend on addressing the climate challenge while protecting its disadvantaged communities. For these reasons, we were disappointed to see that CARB did not discuss any cap-and-trade scenarios during its recent technical workshop.

In addition, the "Scenario Design Options" that CARB staff presented for consideration in developing modeling scenarios did not include cap-and-trade or other market-based solutions. Instead, scenarios were limited to sectoral/engineering-based options and other direct regulations. An economy-wide approach like cap-and-trade achieves climate targets at least-cost - because they do not rely on government intervention, the broad market approach directs investment into sectors and technologies that can reduce emissions most affordably. To that end, a cap-and-trade scenario would illustrate the viable, least-cost option for California to achieve its climate targets. Such an approach should serve as a baseline or reference case, with any deviation from the least-cost option requiring additional justification based on factors unrelated to costs. Instead, the costs of the current scenarios cannot be compared against the least-cost option, thereby forcing



stakeholders to subjectively pick their preferences for sectoral reductions or engineered solutions.

California should not be required to fight for carbon neutrality with one hand tied behind its back. Nor should stakeholders be put in a situation to compare scenarios without complete information on relative costs. IETA therefore urges CARB to explicitly model an aggressive cap-and-trade scenario in the development of California's 2022 Scoping Plan.

Our peer-reviewed paper (Energies 2020, 13, 4972; doi:10.3390/en13184972) reports anaerobic digestion of biomass with the methane/carbon dioxide mixture fed into an Allam Cycle power plant produces electricity with zero emissions plus high pressure pure CO<sub>2</sub> ready for deep aquifer sequestration without additional pressurizing. The income from the electricity, plus income from the sequestered CO<sub>2</sub>, and potentially digestate sales, make this economically interesting.

Hopefully, the digestate (if using pure food waste) can be sold as a high quality fertilizer that can be used on organic and other food crops and rangelands. If the organics are mixed with sewage sludge or other impure wastes, the digestate could be used to enrich shrublands and forests to increase natural sequestration. In addition the digestate could be added as a liquid to other organics in the composting process.

Such profitable use of biomass is essential, especially with the requirement under SB 1383 to divert millions of tons of organic wastes now going to landfills every year.

Hope CARB can model this opportunity for economical carbon negative electricity. You may contact me for more information, references and spreadsheets.
