 We work for a fleet management company that partners with many customers who are affected by the new ACF rules and wanted some clarification.

Many of our partners are under \$50M in revenue, do operate over 50 vehicles but not all 50 of them are over 8500 GVW. Are they subject to ACF?  
 Or is it only if they operate 50 vehicles over 8500 GVW or have over \$50M in revenue.

The over \$50M is easy the question is how many vehicles over 8500 GVW vs just total vehicles makes it confusing to us.
