On behalf of the Rural County Representatives of California (RCRC), we appreciated the opportunity to provide input into the development of the Funding Agricultural Replacement Measures for Emission Reductions (FARMER) Program Guidelines (Guidelines). RCRC is an association of thirty-five rural California counties, and the RCRC Board of Directors is comprised of an elected supervisor from each of those member counties.

In response to comments received on the discussion draft, the proposed FARMER Guidelines has a revised formula distribution. We understand and support the bulk of the funds allocated to the San Joaquin Valley Air Pollution Control District that has the worst air quality and the largest amount of agricultural equipment in the State.
