EXECUTIVE ORDER D-195-19  
Relating to Exemptions Under Section 27156  
Of the Vehicle Code

Paxton Automotive Corporation  
Novi Supercharger Kit

Pursuant to the authority vested in the Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-02-003;

IT IS ORDERED AND RESOLVED; That the installation of the Novi Supercharger Kit manufactured and marketed by Paxton Automotive Corporation, 1300 Beacon Place, Oxnard, CA 93033, has been found not to reduce the effectiveness of the applicable vehicle pollution control system and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for those vehicles listed in Exhibit A of this Executive Order.

The Novi Supercharger Kit includes a supercharger, brackets for mounting, and ducting to route air into the intake manifold. The system also includes, as applicable, an auxiliary fuel pump, replacement fuel injectors, a fuel management unit, reprogramming of the vehicle computer, a manifold air pressure sensor bleed assembly, and an intercooler assembly. The supercharger and crankshaft pulley diameters are listed in Exhibit A of this Executive Order. The supercharger produces a maximum of 8.0 psi of boost pressure at maximum engine speed.

This Executive Order is valid provided that the installation instructions for the Novi Supercharger will not recommend tuning the vehicle to specifications different from those submitted by the device manufacturer.

This Executive Order shall not apply to any Novi Supercharger advertised, offered for sale, sold with, or installed on a motor vehicle prior to or concurrent with the transfer to an ultimate purchaser.

Changes made to the design or operating conditions of the Novi Supercharger, as exempted by the Air Resources Board, which adversely affect the performance of the vehicle's pollution control system shall invalidate this Executive Order.

Marketing of the Novi Supercharger using any identification other than that shown in this Executive Order or marketing of the Novi Supercharger for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the Air

Resources Board. Exemption of the system shall not be construed as exemption to sell, offer for sale, or advertise any component of the kit as an individual device.

This Executive Order does not constitute any opinion as to the effect the use of the Paxton Automotive Corporation Novi Supercharger Kit may have on any warranty either expressed or implied by the vehicle manufacturer.

This Executive Order is granted based on previously submitted test data which showed that the use of the Novi Supercharger Kit does not cause an adverse effect on the vehicles' emissions nor affect the ability of the vehicle's OBDII system to monitor various emissions related functions (Executive Order Numbers D-195-18 and D-213-19).

The ARB reserves the right in the future to review this Executive Order and the exemption provided herein to assure that the exempted add-on or modified part continues to meet the standards and procedures of Title 13, California Code of Regulations, Section 2222, et seq.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE AIR RESOURCES BOARD OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF PAXTON AUTOMOTIVE CORPORATION'S NOVI SUPERCHARGER.

No claim of any kind, such as "Approved by the Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made, after the hearing, that grounds for revocation exist.
