EXECUTIVE ORDER M-27-1
Relating to Certification of New Motorcycles

CALIFORNIA MOTORCYCLE COMPANY, LLC

Pursuant to the authority vested in the Air Resources Board by the Health and Safety Code, Division 26, Part 5, Chapter 2; and,

Pursuant to the authority vested in the undersigned by Health and Safety Code Sections 39515 and 39516 and Executive Order G-45-9;

IT IS ORDERED AND RESOLVED: That 1997 model-year California Motorcycle Company, LLC exhaust emission control systems are certified as described below for four-stroke gasoline-powered motorcycles:

Vehicle models and transmissions are listed on the attachment. Production motorcycles shall be in all material respects the same as those for which certification is granted.

BE IT FURTHER RESOLVED: That the listed vehicle models also comply with "California Evaporative Emission Standards and Test Procedures for 1978 and Subsequent Model Motor Vehicles."


