EXECUTIVE ORDER M-16-7
Relating to Certification of New Motorcycles

WESTWARD INDUSTRIES LTD.

Pursuant to the authority vested in the Air Resources Board by the Health and Safety Code, Division 26, Part 5, Chapter 2; and,

Pursuant to the authority vested in the undersigned by Health and Safety Code Sections 39515 and 39516 and Executive Order G-45-9;

IT IS ORDERED AND RESOLVED: That 1997 model-year Westward Industries Ltd. exhaust emission control systems are certified as described below for four-stroke gasoline-powered motorcycles:


