Relating to Certification of New Motor Vehicles

FREIGHTLINER CORPORATION

Pursuant to the authority vested in the Air Resources Board by Sections 43100, 43102, and 43103 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-3;

IT IS ORDERED AND RESOLVED: That Freightliner Corporation motor vehicles which have a manufacturer's gross vehicle weight rating greater than 8500 pounds are certified using the 1978 engines listed below:

The decal shall display the applicable model year heavy-duty engine exhaust emission standards and the following recommended values:


