EXECUTIVE ORDER A-10-601

Relating to Certification of New Medium-Duty Motor Vehicle Engines

FORD MOTOR COMPANY

Pursuant to the authority vested in the Air Resources Board by Sections 43100, 43102 and 43103 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-3;

IT IS ORDERED AND RESOLVED: That the following 1995 model-year Ford Motor Company Otto-cycle engines are certified for use in motor vehicles with a manufacturer's gross vehicle weight rating (GVWR) of 8,501 to 14,000 pounds:

BE IT FURTHER RESOLVED: That, pursuant to Title 13, California Code of Regulations, Section 1960.1(h)(1)(3), the listed engine models are certified to the exhaust emission standards applicable to 1994 model-year heavy-duty Otto-cycle engines (Title 13, California Code of Regulations, Section 1956.8).

BE IT FURTHER RESOLVED: That the listed engine models comply with the "Malfunction and Diagnostic System for 1988 and Subsequent Model Years..." (Title 13, California Code of Regulations, Section 1968).


BE IT FURTHER RESOLVED: That the listed engine models have been exempted from compliance with the "Malfunction and Diagnostic System Requirements - 1994 and Subsequent Model-Year Passenger Cars, Light-Duty Trucks, and Medium-Duty Vehicles and Engines" pursuant to Title 13, California Code of Regulations, Section 1968.1(m)(2.0) for the aforementioned model year.

BE IT FURTHER RESOLVED: That, for the listed engine models, the manufacturer has submitted the materials to demonstrate certification compliance with the Board's emission control system warranty provisions (Title 13, California Code of Regulations, Section 2035 et seq.).

Engines certified under this Executive Order must conform to all applicable California emission regulations.
