Production engines shall be in all material respects the same as those for which certification is granted.

The FEL(s) is the emission level declared by the manufacturer and serves in lieu of an emission standard for certification purposes in any averaging, banking, or trading (ABT) programs. It will be used for determining compliance of any engine in this family and compliance with such ABT programs.

BE IT FURTHER RESOLVED: That for the listed engine models, the manufacturer has submitted the materials to demonstrate certification compliance with 13 CCR Sections 1965 (emission control labels), and 2035 et seq. (emission control warranty).

**BE IT FURTHER RESOLVED:** That the listed engine models have been certified to the optional reduced PM emission standard(s) listed above pursuant to 13 CCR Section 1956.1 or 1956.8.

**BE IT FURTHER RESOLVED:** That the listed engine models are conditionally certified subject to the following conditions: (1) The Settlement Agreement is in effect; and, (2) The manufacturer is in compliance with all applicable certification requirements of the Settlement Agreement and any modifications thereof.

Engines certified under this Executive Order shall conform to all applicable California emission regulations, and all Settlement Agreement's applicable requirements and any modifications thereof.

The Bureau of Automotive Repair will be notified by copy of this Executive Order.
