Relating to Approval of New Motor Vehicles

FORD MOTOR COMPANY

Pursuant to the authority vested in the Air Resources Board by Sections 39150 and 39151 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Section 39023 of the Health and Safety Code;

IT IS ORDERED AND RESOLVED: That Ford Motor Company exhaust emission control systems for the following additional 1973-model year light-duty motor vehicles are approved for the engine family described below:

Engine Family 429-460 with Exhaust Gas Recirculation

Engine Size - 429 CID with Automatic Transmission


Models: Ford - Ranch Wagon, Country Sedan and Squire.
Mercury - Monterey Wagon, Marquis Wagon and
Colony Park.

In accordance with Section 111 E. of the California Exhaust Emission Standards and Test Procedures for 1973 through 1976 Model Gasoline-Powered Light-Duty Motor Vehicles, the manufacturer is required to inform the Air Resources Board of any production changes which will affect emissions.

Supplemental information sheets are attached to this order which include tuneup specifications and emission control system data.

The Department of Motor Vehicles, the California Highway Patrol, and the Bureau of Automotive Repair of the Department of Consumer Affairs will be notified of this approval by copy of this order and attachment.
