EXECUTIVE ORDER A-6-32-1
Relating to Approval of New Motor Vehicles

GENERAL MOTORS CORPORATION

Pursuant to the authority vested in the Air Resources Board by Sections 39150 and 39151 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Section 39023 of the Health and Safety Code and Executive Order G-45-1;

IT IS ORDERED AND RESOLVED: That General Motors Corporation exhaust emission control systems for 1975 model-year passenger cars are approved for the engine family described below:

- Engine Family: 11K43
- Engine: 350 CID
- Transmission: 3 or 4-speed manual
- Exhaust Emission Control Systems: Converter air injection, exhaust gas recirculation, early fuel evaporation, oxidation catalyst

- Models: Chevrolet
- Camaro
 - Camaro "Type LT"
 - Nova 2-Door Coupe
 - Nova 2-Door Hatchback Coupe
 - Nova 4-Door Sedan
 - Nova Custom 2-Door Coupe
 - Nova Custom 2-Door Hatchback Coupe
 - Nova Custom 4-Door Sedan

These vehicles are in addition to those previously approved for this engine family.

Vehicles approved under this Executive Order must conform to all applicable California emission regulations.

The Department of Motor Vehicles, the California Highway Patrol, and the Bureau of Automotive Repair will be notified by copy of this order and attachment.
