EXECUTIVE ORDER A-120-2
Relating to Certification of New Motor Vehicles

DIVERSIFIED FOUR WHEEL DRIVE, INC.

Pursuant to the authority vested in the Air Resources Board by Sections 43100, 43102, and 43103 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-3;

IT IS ORDERED AND RESOLVED: That Diversified Four Wheel Drive, Inc. exhaust emission control systems for 1976 model-year light-duty trucks are certified for the engine family described below:

Engine Family: Toyo Kogyo CVBT
Engine: 109.6 CID
Transmission: 4 and 5-Speed Manual
Exhaust Emission Control Systems: Air Injection, Exhaust Gas
Recirculation, Oxidation Catalyst

Models: Tiger 4 X 4 (4-Speed)
Tiger 4 x 4 (5-Speed)

The following are the recommended values to be listed on the window decal required by California Assembly-Line Test Procedures for 1976 model-year vehicles:
