IT IS ORDERED AND RESOLVED: That Toyo Kogyo Co., LTD. exhaust emission control systems for 1978 model-year light duty trucks are certified for the vehicles described below:

Exhaust Emission Control Systems: Air Injection, Exhaust Gas
Recirculation, Oxidation Catalyst

BE IT FURTHER RESOLVED: That the above models also comply with "California Evaporative Emission Standards and Test Procedures for 1978 and Subsequent Model Gasoline-powered Motor Vehicles except Motorcycles".


