This notice is to inform you of date changes and a location change for the previously announced public workshop to discuss possible regulatory activities to reduce diesel particulate matter (PM) emissions from cargo handling equipment at intermodal facilities in California, including ports and rail yards. We will discuss the motivation for this undertaking, the expected timeline and process for regulation development, and options that are available to reduce diesel PM emissions from cargo handling equipment. We will also discuss several efforts currently underway including creating an emissions inventory for cargo handling equipment, available emission control technologies, and activities already underway by terminal operators at California's ports to reduce emissions.

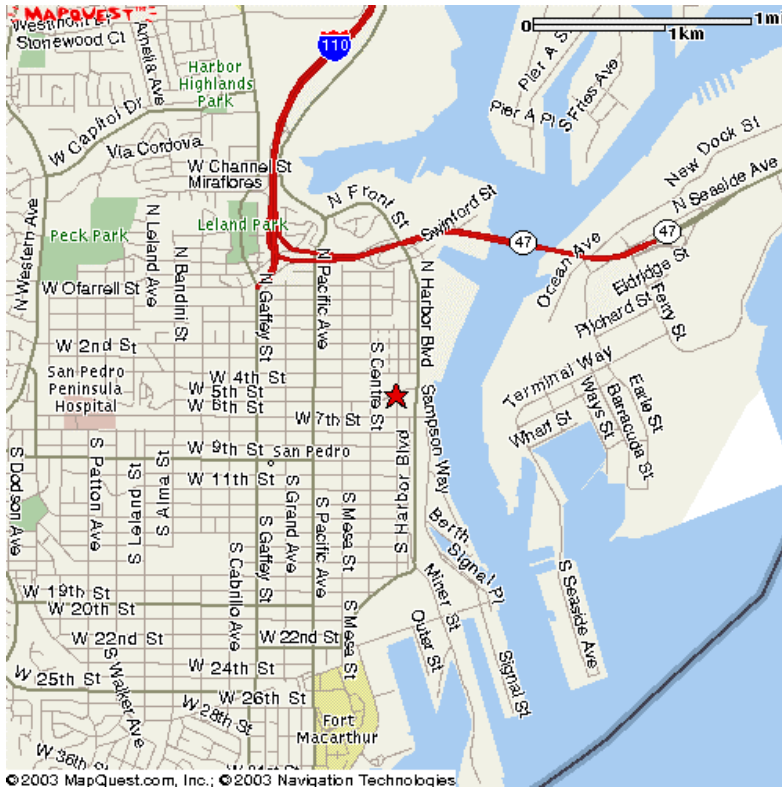

Take the CA-47 exit to Vincent Thomas Bridge/Terminal Island – Long Beach.

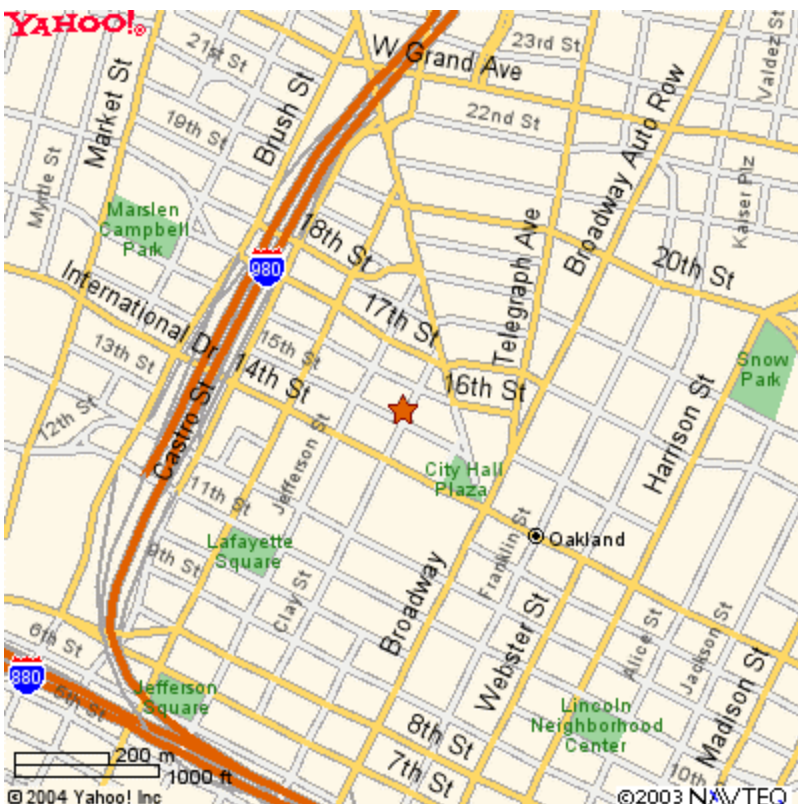
Merge to the right and take the Harbor Blvd exit. Turn Right onto Harbor Blvd.

Take I-880/I-980 in the East Bay.

Take the Broadway exit toward Downtown.

Take the ramp toward Alameda.

Merge onto Broadway.

Turn Left onto 12th St.

Turn Right onto Clay St.
