## Dear Sir or Madam:

The California Air Resources Board (ARB) staff invites you to participate in a public workshop on September 19, 2006, to discuss draft regulatory language for amendments to the Airborne Toxic Control Measure for Emissions of Perchloroethylene from Dry Cleaning Operations.

On May 25, 2006, the ARB held a meeting to discuss the proposed amendments to the Airborne Toxic Control Measure for Emissions of Perchloroethylene from Dry Cleaning Operations (Dry Cleaning ATCM). The Board heard testimony from many interested parties, including the affected industries, industry associations, environmental groups, local air pollution control districts and other interested individuals. Although some of the testimony was supportive of ARB staff's proposal, many commenters suggested that ARB phase out the use of perchloroethylene (Perc) in dry cleaning operations primarily because of its toxic effects and the availability of alternative technologies.

After nearing public comments and considering staff's proposal, the Board directed staff to return to them with a proposal to phase out Perc from dry cleaning operations. The Board also directed staff to consider the cost impacts of the proposal to the industry and to provide information on any available programs which provide financial assistance to California dry cleaners. This workshop will provide the public with the staff's draft regulatory proposal to phase out Perc in dry cleaning operations.
